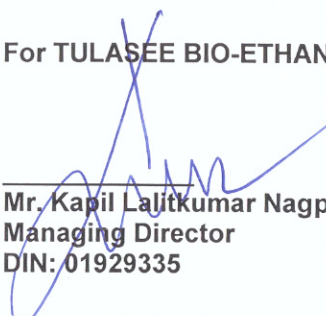

LIMITED REVIEW REPORT OF TULASEE BIO-ETHANOL LIMITED

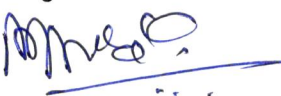
